

## OCC HOUSING IMMUNIZATION RECOMMENDATIONS

The California Department of Public Health (CDPH) recommends colleges and university students obtain the vaccinations and screening for those diseases that can be passed on to others by respiratory transmission.



### DUE OCTOBER 1, 2020

All Housing Students are **RECOMMENDED** to:

- Obtain the Vaccines Listed Below
- Undergo Tuberculosis Risk Screening
- Upload Your Records to the Student Health Portal

#### RECOMMENDED VACCINATION

#### PROOF OF IMMUNIZATION

**Measles, Mumps and Rubella (MMR)**

2 doses; **first dose on or after age one** - OR - Titer (blood test) showing immunity.

**Varicella (Chickenpox)**

*History of Chickenpox does not satisfy the recommendation.*

2 doses; **first dose on or after age one** -OR – Titer (blood test) showing immunity.

**Tetanus, Diphtheria and Pertussis (Tdap)**

*Td or Dta does not satisfy the recommendation.*

1 dose **on or after age 10.**

**Meningococcal Conjugate Serogroups A, C, Y, & W-135**

*For students age 21 years and younger only.*

1 dose **on or after age 16** for all students that are under 22 years of age.

*Students 22 or older may leave blank.*

**All students must read and sign the Meningitis Information form.**

**Screening Questionnaire for Tuberculosis**

*Log in to the Student Health Portal, click "My Forms." Click "OCC Tuberculosis (TB) Risk Assessment" and answer the questions.*

**All incoming students are recommended to complete the TB screening questionnaire on the Student Health Portal.**

*Students who have any "yes" answers on the assessment are at higher risk for TB infection and are recommended to submit documentation of either skin or blood testing for TB, done within 6 months of the move-in date. Those with a previous positive TB test are recommended to submit documentation of a chest x-ray done within 6 months of the move-in date.*

**Seasonal Influenza (Flu)**

1 dose on or after August 1, 2020

# HOW TO COMPLY WITH THE OCC HOUSING IMMUNIZATION RECOMMENDATIONS:

1. Be prepared! Gather all of the info you'll need to complete your recommendations online.
2. Go to the OCC Housing Health Clearances website and sign into the Student Health Portal.
3. Once you are logged in, from Home page, click My Forms, fill out the Housing Clearance Consent form, Meningitis Information form, TB Risk Assessment form, and OCC Housing Immunizations form.
4. Enter all of the requested dates, immunization information, and submit TB screening.
5. Upload Images/PDF files of your immunization records, laboratory tests, and/or chest x-ray by clicking on the "Select File" button at the end of the forms.
6. You can check your immunization status from the Student Health Portal home page.
